United Lutheran PARISH HALL Rental Agreement and Rules

- 1. Running, Jumping, and water games are not permitted inside the Parish Hall.
- 2. No smoking or vaping is permitted inside the Parish Hall.
- 3. No alcoholic beverages are allowed.
- 4. No Thumb tacks are to be placed on the walls, woodwork, or tables.
- 5. Tables are to be left as you found them
- 6. Chairs are to be stacked properly on the caddies.
- 7. No food or drinks are to be left in the refrigerator or freezer.
- 8. All dishes are to be washed and put in the cabinets where they were found.
- 9. Dish clothes, towels, and pot holders, etc. are to be supplied by the renter.
- 10. Counter tops are to be wiped clean and free of utensils and dishes.
- 11. Stove tops and ovens are to be turned off and left in a clean condition.
- 12. The floor must be swept and all liquid spills must be cleaned up.
- 13. All lights are to be turned off when leaving.
- 14. Return thermostat to 50 degrees upon leaving and turn air conditioning off when leaving the building.
- 15. Paper cups, napkins, etc. Will be supplied by the user.
- 16. The ball field and playground will be shared equally by all parties using the church facilities.
- 17. All trash is to be placed in the provided containers lined with plastic bags provided in a drawer under the countertop and taken to the supplied dumpster up by the main church.
- 18. Bathrooms are to be shared with renters of the grove.
- 19. Please check restrooms to ensure that they are flushed clean when leaving the property and keep the bathroom doors open.
- 20. Keys for the parish hall are located inside the front of the church on the right wall inside a small black mailbox. Please return them when finished with rental.
- 21. There Is an AED onsite in the main church located in the Sunday School wing.

Rental cost for the Parish Hall is \$100.00 per day.
